**Purpose:** This MoU aims to establish a collaboration between Danish Maritime and Hochschule Flensburg. Both parties acknowledge that close collaboration will contribute to the promotion of knowledge sharing, research, innovation, and education in relevant areas.

**Duration:** This MoU shall come into effect on the date of signing and remain valid until September 2026, with the possibility of extension by mutual agreement.

#### **Areas of Collaboration:**

(a) **Research and Development:** Danish Maritime and Hochschule Flensburg will collaborate on research and development projects relevant to both parties. They will exchange knowledge, resources, and facilities to promote joint research activities.

(b) **Education and Teaching:** Danish Maritime and Hochschule Flensburg will collaborate in developing and implementing educational programs, courses, or workshops that enhance skills and knowledge within the Danish Maritimes field.

(c) **Internships and Employment:** Danish Maritime and Hochschule Flensburg will collaborate to facilitate internships, student jobs, or job opportunities for the University's students and graduates, enabling them to gain practical experience and a smooth transition into the workforce.

(d) **Knowledge Sharing and Networking:** Danish Maritime and Hochschule Flensburg will foster knowledge sharing and networking opportunities through joint conferences, seminars, or events.

### Resources:

(a) Financial Resources: Both parties will seek external funding sources to support joint research projects when agreed between the parties.

b) Material Resources: Danish Maritime and Hochschule Flensburg will provide facilities, equipment, or laboratories as needed for joint activities.

(c) Personnel and Expertise: Both parties will contribute relevant experts, researchers, or lecturers to the collaboration.

Confidentiality: Both parties undertake to maintain the confidentiality of all information and data exchanged in connection with the collaboration. Neither party shall disclose or publish such information without prior written permission from the other party.

Reporting and Evaluation: Danish Maritime and Hochschule Flensburg will regularly evaluate the collaboration and report on progress, results, and any challenges. They will meet at least once a year to discuss the collaboration and adjust goals and activities as needed.

Termination of MoU: The agreement may be terminated before the specified end date by both parties upon written notice within one-month prior notice. Any unfinished activities or obligations will be completed in accordance with mutual agreement between the parties.

The Memorandum of Understanding is not legally binding.

This collaboration agreement constitutes the entire agreement between Danish Maritime and Hochschule Flensburg.


